Did you know cyber thieves hacked nearly 45 million healthcare records in 2022?

Medical records are virtual goldmines for hackers because they contain all the information needed to steal a patient's identity for personal and financial profit. Meanwhile, theft victims are left trying to clean up the mess and financial entanglements, which can persist for years.

Healthcare records include patients' full names, address history, financial information, and Social Security numbers. With this information, thieves can easily take out a loan or establish a line of credit under the patient's name. They can also use the information to access medical care in someone else's name and submit claims under the original policyholder's medical insurance; in other words, the insurance pays for someone who is not entitled.

Telltale signs that you're a medical identity victim:

Medical bills for services you did not receive

- New medications, blood type, allergies, or other details that you did not report to your provider appearing on your medical record
- A notice from your insurance carrier stating you have maxed out your policy limits, even though you didn't use services
- Higher healthcare insurance premiums with no explanation.

Fast action can help mitigate damage.

As soon as you find out that your medical records are compromised, act quickly. First, could you find out what personal information the thief used to access your data? You'll need to contact the right parties to let them know your information is unsafe. For example, alert your insurance provider as quickly as possible if your medical insurance card is lost or stolen.

Next, report the breach of your medical records to all your healthcare providers and forward copies of the documents showing the erroneous information. Write a request to your insurance providers to correct your records. Send copies of the records in question. File a medical identity theft complaint with the Federal Trade Commission. Finally, remember to file a police report.
